**Please read all 8 parts of This Agreement.**

1. TAMARKIN AUCTIONS is pleased to accept bids by email and by letter mail. Please list on the form the Lot number and your corresponding bid (before and not including the Buyer's Premium). Please use whole dollar amounts and enter the maximum bid that you wish to have us execute on your behalf. Your bid will NOT include the 19.5% buyer's premium.
2. TAMARKIN AUCTIONS will treat mail and email bids as the maximum, which the buyer is willing to pay and will bid only enough to exceed the reserve price or the next previous bid. All mail and on-line bids will be executed at the lowest possible price consistent with the rules of the auction and the bid increments.
3. There is a Buyer's Premium of 19.5%. Bidders who bid on the Internet pay a 22% Buyer's Premium. Local sales tax will also be added to the total due, as applicable. There is a 10.25% sales tax on items delivered in Illinois. There is no sales tax on items delivered outside the State of Illinois.

4. TAMARKIN AUCTIONS undertakes the insured shipment of auction purchases only as a courtesy to buyers. The buyer pays UPS or DHL freight and insurance costs and is normally charged the direct cost of the shipping plus a modest additional fee for packaging and handling. All risk of loss passes to the buyer upon shipment.

5. Payment can be made by wire transfer, VISA, MasterCard, check and bank wire transfer. Please refer to auction catalogue for payment details.

6. All email and mailed letter bids must be received by 5:00 p.m. CST Friday, November 18, 2022.

7. TAMARKIN AUCTIONS shall not be liable to either the buyer or to the seller for any neglect or failure to execute a mail bid. If two mail bids are identical, the bid first received will be used.

8. By signing this bid form, you agree to pay for purchases resulting from your bid in accordance with the Terms & Conditions printed in the Auction Catalogue. You also agree to pay the 19.5% Buyers Premium (22% for internet real-time bidders) and the appropriate shipping costs and any local sales tax that might be due. You understand that these bids will be executed by TAMARKIN AUCTIONS, INC., as a courtesy to absentee bidders, and that no legal responsibility shall lie with the auctioneer or the firm if these bids are not executed. You are responsible for your written bids, including any errors on your part and all sales are final. You understand that all items are offered "as is," that there is no return privilege, and that all sales are final.
